What is the Spatial Reference Council?

The Spatial Reference Council is the governing body of the Spatial Reference Center of Washington (SRCW). The Council's Executive Committee is the Board of Directors for the SRCW.

What is the SRCW?

The Spatial Reference Center of Washington (SRCW) is a nonprofit corporation dedicated to the planning, implementation, and maintenance of an accurate state-of-the-art network of GPS control stations necessary to meet the demands of government and private businesses for a reliable spatial reference system in the state of Washington. These activities are largely funded by the National Geodetic Survey's Height Modernization program.

Why should I join the Spatial Reference Council?

Membership in the Council will allow input and direction to the Spatial Reference Center of Washington. Membership is a shared involvement with an extensive network that benefits many different public and private interests across the state.

Who can join?

Membership is open to organizations and individuals. Organizations must designate an individual to be the organization's representative to the Council. Organizations shall be voting members and their designated representative may serve as an Officer of the Council. Individual members shall have no voting rights and may not be an Officer of the Council.

What is the application process?

Organizations and individuals must submit a completed application and payment including the initiation fee of \$1000 or \$100 respectively which includes the first year's dues. Followed by respective annual dues of \$200 and \$50.

Does the Spatial Reference Council accept grants or donations?
